

CIPHE Water Regulations Training Offer Sponsored by Northern Ireland Water

Terms & Conditions

This offer is only available to CIPHE members operating in Northern Ireland whose business/soletrading business intends to join WaterSafe when they successfully complete the water regulations assessment. To be eligible for the course individuals must:

- Provide plumbing services within Northern Ireland
- As a minimum, have successfully completed an NVQ Level 2 in Mechanical Engineer Services (plumbing) (6089)
- Be a member of CIPHE.

This course is being sponsored by Northern Ireland Water, who are keen to increase WaterSafe membership within their area of supply.

WRAS will deliver the training and assessment in the knowledge of the Water Regulations as developed by BPEC Services Ltd.

The course normally costs £127 per person plus VAT. This includes the cost of the BPEC course booklet which costs £54.50. **You will be liable to pay this cost if you don't attend the course once booked; if you fail the course or if you don't go on to register with the WaterSafe scheme.**

For businesses to be eligible to join WaterSafe you must also be able to demonstrate that you:

- have at least one qualified individual who is recognised by WaterSafe for every five employees undertaking water supply installation work.
- will commit to send only qualified and WaterSafe-recognised individuals to respond to WaterSafe-generated work
- Have £2 million of public liability insurance and, where appropriate, £5 million of employers' liability cover.

Four to six weeks prior to the assessment, the candidate needs to be in possession of the distance learning package for Water Regulations. WRAS will provide this only once a booking form is received and a place confirmed.

Each delegate needs to read the booklet and be familiar with its contents before they attend the training and assessment course.

On gaining the accreditation your business must join WaterSafe through CIPHE to qualify for the free training and assessment offer.

Although the training is suitable for anyone who has plumbing knowledge and is working within the plumbing and heating sector, only those who have the qualifications accepted by WaterSafe will be able to join the scheme.

Check that your qualifications are accepted prior to booking the assessment.

Training Day

The training will be held at:

- The training and assessment session starts with registration at 9am for a 9:30am start.
- There will be an overview and training period until around noon followed by a break of about half an hour.
- After the break there will be an open book assessment lasting 75 mins which consists of 40 multichoice questions split into two sections.

To gain the accreditation the candidate must achieve 80% in both sections. Candidates who achieve less than 70% in the first attempt in one or both sections have failed and will therefore need to re-sit at a later date.

However, candidates who achieve between 70% and 80% in each section at the first attempt may have a second attempt to achieve the 80% required on the day.
